

## **PROJECT OVERVIEW**

The Bellechasse Sector in the southwest part of the Rosemont – La Petite Patrie borough is one characterized by its presence of a diversity of diversified economic activities from industry and transportation to office space. It is currently subject to a planning initiative that originated in 2006 that looked to redevelop the area, in coherence with the plans for a new STM center for transport. These plans were on hold from 2012 until the confirmation of the new STM Transport Center, and its construction began in 2018.
